### 16. SCHOOL IMPROVEMENT PLAN (SIP) AND SELF EVALUATION

This item was not discussed at the meeting.

### 17. SCHOOL NEWSLETTER

The school newsletter was received and noted. Governors offered their congratulations to the Head Boy and Girl.

### 18. WELLBEING OF STUDENTS

The Staff Governor was absent due to illness, but Mr Cormack provided an update. Governors were advised that the overwhelming majority of pupils were doing really well and had a strong start to the year. Students were benefitting from the return of extra-curricular activities and zones had been removed, which made a more pleasant and productive atmosphere for learning. It was noted, however, that there was a small cohort of students where lockdown had significantly impacted families, and this had affected either their mental or physical wellbeing. Staff were working with the affected pupils.

Q: How many pupils are affected?

A: Approximately 10-12 in each year group.

Governors were informed that it could be very upsetting for staff to deal with some of the issues being brought into school, but all identified pupils were receiving a package of support.

Mr Cormack advised that circumstances had meant that more protective measures had had to be brought back into place; these were now being relaxed but had put a further strain on both staff and pupils, although the majority were managing it very well.

Mr Sheeran advised that strains were being seen elsewhere in the education sector, particularly as the burden of public health on schools since the pandemic began was extraordinary. Mr Sheeran advised Governors of the extraordinary and absolutely superb efforts of leadership in school, particularly as there was no end on the horizon.

Discussion took place about the long term impact of the pandemic and Governors raised concerns about potential students and staff whose issues were not yet identified, particularly around mental health issues.

- Q: Do we have mental health first aiders and are they empowered to take action for both students and colleagues?
- A: We do have mental health first aiders who work directly with staff. We also have Barnados counselling for staff and also utilise the Employer Support Network. There is a lot of pressure on staff, including around Ofsted and accountability, as well as dealing with some horrific issues with families.

Mrs Kellett left the meeting at 6.15pm.

- Q: Is mental health care available for those students worse affected?
- A: We support in school as best we can, but externally no; the waiting lists are incredible.
