#### Part 1

1. Apologies and Consideration of Consent to Absence

Apologies were received from Mr Anders, Mrs Bellis and Mr Van Der Laan. Governors consented to their absence.

The meeting was chaired by Mrs Hill in the absence of Mr Anders.

The meeting was quorate, there being 7 Governors of the 11 in post present at the meeting.

Mrs Hill welcomed the newly appointed staff Governor Mr Corey Gerrard to the board, and the board expressed their thanks to the previous Staff Governor Mr James Hunt for all his contributions during his time as Governor.

#### 2. Declarations of Interest

No new declarations of interest were declared.

# 3. Governor Membership

At the previous board meeting on 17 October 2024, the board voted that Justine Kellett's term of office (which was due to expire) be extended for the usual period of office. Governor Hub has not been updated to reflect this yet.

Action: Governor Services to update Governor Hub with Mrs Kellett's new term of office

Mr Cormack and Mrs Hill updated Governors regarding vacancies.

Mr Cormack has approached two people who both have children at Cowley.

<u>Linda</u> – Former HMI and a former Head Teacher. Has turned a school around from inadequate to outstanding. Is currently the Assistant Principal at Little Lever. Mrs Hill and Mr Cormack gave her a tour of the college and think she will be a real asset to the board. She will likely also be part of Quality of Education and Pupil Wellbeing Committees too. Her daughter is in Sixth Form Year 12, she did not attend Cowley 11-16, she went to a different secondary school.

<u>Clare</u> – Associate Professor who is currently is in charge of the medical programme with Chester Medical School. Mrs Hill and Mr Cormack have also met with her today. Both recommend her to join the board, she has good expertise and links. Her child is currently in Year 8.

Mrs Hill and Mr Cormack recommend to the board that both Linda and Clare should be appointed as Governors.

Question: In terms of the Finance Committee, is this the one we most need

expertise in?

Answer: Predominantly yes. Both individuals run departments etc, so are well

used to this.

Governors voted to appoint both Linda and Clare as Co-Opted Governors.

Resolved: Linda and Clare appointed as Co-Opted Governors for the usual

term of office.

- C6 and C7. Mr Cormack said there is going to be some training for Governors regarding being on Permanent Exclusions Panel. At the last Permanent Exclusions Panel we had to use a Governor from another school as we were unable to fulfil thr panel from our own Governors.

#### Quality of Education Committee Meeting held on 5 December 2024

- Mr Watkins gave his first update regarding KS5 performance and transition.
- Mr Cormack gave an update regarding KS4. Attendance and outcomes focused on, data looked at.

- Talked about Committee having sight of students who have thrived at Cowley.
   Mr Hewlett has been tasked with going away and talking to students, success stories to next Committee Meetings.
- Mr Cormack advised there is a delay with IDSR for KS4. We have looked at CISR data – collaborative, analytics data which a lot of schools used. Since that meeting DFE has released some unvalidated data, but this is different to CISR data. We are currently going through all the CISR / DFE data to identify where any discrepancy lies / to get clarity.
- When the IDSR is released, Governors will need to review and discuss this.

Question: When will the next Ofsted inspection be?

Answer: Within 12 months.

# 14. Pupil Wellbeing

Mr Cormack reported that the Year 7 cohort has settled very well. Excellent attendance just below 96%. Mr Cormack commended the transition team.

Performing Arts – there was another performance last night.

Challenges ongoing – students with home issues / mental health etc. Pastoral team working very hard.

Mr Gerrard praised the Year 7s in church today for their great behaviour and also praised the year teams in dealing with challenging behaviour.

Mr Cormack reported that "The Cowley Way" introduced this year (behaviours and expectations) is making a difference.

Sad news. One pupil was knocked over by a car. A few students have had parental bereavements. The pastoral care has been great.

Question: Mobile phone policy – how is it all going?

Answer: Still going well. Pupils behaviour at lunch is more social etc. It is

good that we no longer have pupils filming fights etc. Phone detectors are being used. We have been asked on a number of occasions to be

filmed by film crews, but have said no.

Question: Are students realising the benefit of the policy? Talking to friends more

etc?

Answer: We do not have any tangible evidence yet, but we have not had pupils

at the last PBW Committee due to the date change, will ask at next

one.

Mrs Ahmed commented that her own child has joined more extra-curricular clubs and has developed a real interest in performing arts. Mr Gerrard said it was a record attendance / involvement in the Performing Arts event last night.

Governors agreed that we need to talk to the pupils and explain to them the benefits they are getting from the policy, as they may not realise.

Michelle Foster at Wigan Council has done some training online regarding Academisation. Mr Arnold attended this and highly commended her for the quality of the training provided.
